STUDY PROGRAMME IN ENGLISH FOR WHICH THE CALL HAS BEEN ANNOUNCED:

Master in European Integration, in English - 60 ECTS

Master in European Integration, in English – 120 ECTS

NUMBER OF VACANCIES FOR STUDENTS::

The total number of 60 students, more specifically, 5 students whose education is financed from the budget and 55 self-financing students, can be enrolled in the study programme of the master academic studies - Master in European Integration of 60 ECTS credits.

A total of 10 self-financing students can be enrolled in the study programme of master academic studies - Master in European Integration of 120 ECTS credits.

* The Government of the Republic of Serbia has not passed a Decision on the number of vacancies for student admission to the first year of study programmes financed from the budget for higher education institutions founded by the Republic for the academic year of 2023/2024. If budget places are not approved, they will be added to the number of self-financing students. The number of self-financing places will change so that the total number of students enrolling in the study program remains unchanged.

CONDITIONS:

Candidates eligible for enrollment in the one-year master in European Integration study programme are those who completed undergraduate studies at the University of Belgrade, Faculty of Law, i.e., persons with completed four-year undergraduate studies under the current laws before the enactment of the Law on Higher Education; candidates with completed undergraduate studies and scored 240 ECTS credits at another law or related faculties of social sciences and humanities, whose founder is the Republic of Serbia or the Republic of Srpska; as well as candidates who have completed the previous level of studies at other law or related faculties of social sciences and humanities, if the curricula of those faculties coincide with the study programme of the University of Belgrade, Faculty of Law (with the obligation to take appropriate differential exams as prerequisites for enrollment, in accordance with the decisions of the Academic and Scientific Council).

Candidates who have completed integrated studies or three-year undergraduate studies and two-year master academic studies (180 US + 120 MAS), having obtained at least 300 ECTS credits, also have the right to enroll.

Students who have completed undergraduate studies in the field of law or other social sciences and humanities and achieved at least 180 ECTS credits are entitled to enroll in the two-year master programme.

The condition for enrollment in both master programmes for candidates who have completed undergraduate studies at other faculties of social sciences and humanities whose founder is not the Republic of Serbia or the Republic of Srpska, and in case the curricula of those faculties do not match the study programme of the University of Belgrade, Faculty of Law, is

to pass the following differential exams before enrollment: Introduction into Jurisprudence; Constitutional Law; Introduction to Civil Law and International Public Law.

Prerequisite for enrollment is a proof of English language knowledge on the higher level of the competence = B2 – certificate Cambridge Advanced Certificate in English (CAE) or IELTS (International English Language Testing System), completed high school education in English language or a test of knowledge of English.

CRITERIA FOR DETERMINING THE ORDER OF CANDIDATES ON THE RANKING LIST:

The order of applicants for enrollment is determined on the basis of the overall average grade, the length of study and the corpus of subjects of importance for studies in the applied module.

Candidates can score 120 points, based on the overall average grade, length of study and the corpus of subjects of importance for studies in the applied module. The overall average grade refers to the average grade from the previous level of study multiplied by 10. On this basis, candidates can score a maximum of 100 points in total. Based on the length of study, candidates can score a maximum of 10 points. Based on the corpus of subjects of importance for studies in the applied module, candidates can score a maximum of 10 points. The corpus of subjects of importance for studies in the applied module consists of subjects of the previously completed study programme, the assessment of which is performed by the competent professional body of the Faculty.

The overall average grade will be multiplied by 10.

Corpus of subjects of importance for studies in the applied module:

These are the subjects of the previously completed study programme, the assessment of which is performed by the competent professional body of the Faculty, and which are important for studies in the applied module:

- if the studies were completed at the Faculty of Law whose founder is the Republic of Serbia or the Republic of Srpska: 10 points;
- if the studies have been completed at another law or related faculties of social sciences and humanities (with the potential obligation to take differential exams): 2 points.

Differential exams for candidates who have graduated from another law or related faculties of social sciences and humanities are determined by the Decision of the Academic and Scientific Council on enrollment in master academic studies of candidates who have not graduated from the University of Belgrade, Faculty of Law and the decision of the Academic and Scientific Council on specifying the conditions for enrollment in the master academic studies.

Master academic studies in Public Procurement Management (Master in Public Procurement Management) 60 ECTS

Joint study programme of the "Tor Vergata" University in Rome — Department of Economics and Finance and the University of Belgrade — Faculty of Law

* Note: The study programme will be realized if at least 20 students are enrolled.

NUMBER OF VACANCIES FOR STUDENTS:

A total of 50 self-financing students can enroll in the study programme of Master Academic Studies in Public Procurement Management.

ENROLLMENT REQUIREMENTS:

Candidates who have acquired the appropriate level of education, which is a necessary requirement for enrollment in the second level of studies in Serbia and third level of studies in Italy, have the right to enroll:

- with completed undergraduate studies and obtained 240 ECTS, i.e., persons with completed four-year undergraduate studies under the current laws before the enactment of the Law on Higher Education, as well as candidates who have completed integrated studies or three-year undergraduate studies and two-year master academic studies (180 US + 120 MAS), having obtained at least 300 ECTS credits. Candidates must have an active knowledge of English.

Prerequisite for enrollment is a proof of English language knowledge on the higher level of the competence = B2 - certificate Cambridge Advanced Certificate in English (CAE) or IELTS (International English Language Testing System), completed high school education in English language or a test of knowledge of English.

More detailed enrollment requirements can be found on the bulletin board and website.

CRITERIA FOR DETERMINING THE ORDER OF CANDIDATES ON THE RANKING LIST:

The order of candidates is determined on the basis of the overall average grade, length of study, biographical data, knowledge of English and work experience in the field of public procurement.

The candidates can score a maximum of 200 points.

The overall average grade refers to the average grade from the previous level of study multiplied by 10.

On this basis, candidates may score a maximum of 100 points.

Based on the length of study, candidates may score a maximum of 10 points.

The total number of points awarded by the Enrollment Commission based on the conducted interview by evaluating biographical data, knowledge of English and work experience is 90.
